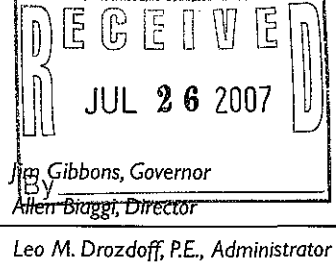

Dear Mr. Paris:

The NDEP has received and reviewed BRC's correspondence identified above and provides comments below.

- The proposed monitoring approach deviates from the approved *Perimeter Air Monitoring Plan* (PAMP) which is Appendix B of the September 2006 *Corrective Action Plan*. Specifically, the proposed approach does not include the collection of PUF samples. These PUF samples are collected for analysis of dioxins/furans; SVOCs/PAHs; PCBs; and pesticides. NDEP requests that the approved PAMP methodology be implemented for this round of sampling.
- If there are additional deviations which have not been noted they should also be resolved. It is the expectation of the NDEP that the methodology in the PAMP will be explicitly followed.
- If this is acceptable to BRC please confirm this in writing to the NDEP and proceed with implementation of the scope of work.
