1. Introduction

This Quarterly Progress Report is being submitted to the Nevada Division of Environmental Protection (NDEP) pursuant to the requirements of Paragraphs 1 and 2 of Section XIII of the AOC3 executed between the Parties and NDEP on February 15, 2006. The format of this report is based on the requirements stated in Paragraph 1 of Section XIII. This report covers activities between April 1 and June 30, 2011.

2. Actions Taken Towards Achieving Compliance

In addition to the various documents submitted to the NDEP discussed below, BRC and NDEP held meetings and telephone calls in order to achieve progress on project activities. Telephone meetings were held between the BRC management, the BRC Project Manager and the NDEP Project Manager (occasionally along with representatives from the City of Henderson as well as consultants representing the prospective property buyer) roughly every two weeks. Minutes of these meetings are maintained separately.

Several iterative rounds of limited remediation activities involving scraping, as needed, for the Phase I development/First 8 Rows sub-area were conducted, along with follow-up confirmation sampling. The CAMU (Phase V only) remains open in order to accept wastes as needed and will remain open till remediation activities cease or diminish. BRC and NDEP had several discussions relating to CAMU maintenance items relating to storm-water impacts and spot erosion due to rainfall and with regards to pumping of residual liquids from the Phase I vadose zone sump. BRC continues to inspect and maintain the CAMU.

NDEP reissued the prior NFAs for Parcels 4A and 4B in the new format.

Separately, BRC: (a) continued discussions with the NDEP regarding the pending NFA for the Galleria High School sub-area – in particular, the issue of proper determination of COPCs for this sub-area (and similarly situated sub-areas). In this regard, BRC has retained Dr. Jonathan Myers of Shaw Environmental to conduct geochemical statistical analyses; (b) had discussions with the NDEP relating to soil flux and is awaiting NDEP comments on this item; (c) submitted a revised report containing data for the second round of semi-annual CAMU area groundwater monitoring; (d) obtained comments from the NDEP on the Eastside groundwater Indicator Parameters Report; (e) is awaiting comments from the NDEP on the Eastside Upgradient Report; (f) submitted the report for the third semi-annual CAMU groundwater baseline data collection event; (g) submitted the DU/COPC selection package for the Southern RIBs area to the NDEP; and (h) initiated development of the CSM to support the RAS for Eastside groundwater.

Results of previous confirmation sampling were received and analyzed and appropriate data validation activities also occurred.

3. Sampling Conducted

BRC collected various samples in support of the remediation effort including confirmation and re-confirmation soil samples.

4. Work Plans and Other Deliverables Submitted Including Modifications

Attachment A shows a list of all documents that were submitted to NDEP in this period. Attachment B shows a list of all NDEP documents received during this period.

5. Actions Scheduled for Next Quarter

Activities planned include: continuing scraping of the various polygons in the First 8 Rows sub-area as needed; completing the DU/COPC selection for this sub-area after final confirmation samples are obtained; obtaining NDEP concurrence on the DU/COPC selection documents for Galleria High School site and Southern RIBs sub-areas; submitting HRAs for the Galleria HS site and the Southern RIBs area; finalizing the path-forward on side-by-side flux and soil gas analysis; obtaining NDEP concurrence on the report for the third round semi-annual CAMU area groundwater monitoring report; planning for the fourth and final baseline sampling event for the CAMU; obtaining approval of the various Eastside groundwater documents including the Upgradient and Indicator Compounds tech memos; and completion of the methodology to address COPC selection in instances where local background levels may be elevated as compared to the currently-approved background data sets (such as the Galleria HS site).

The following Work Plans and Other Deliverables are planned to be submitted to the NDEP in the next period:

- (i) Revised Project Schedule (updated as needed). Since there are a small number of current activities, a list of the current activities along with status and schedule is attached to this report.
 - (ii) Various Data Validation Summary Reports, as needed.
 - (iii) Various documents discussed above.

Additional documents may also be submitted depending on project progress.

6. Completions, Delays and Mitigations

The remediation effort is generally on schedule. However, BRC will await NDEP approvals on outstanding documents and NFAs before planning for completing remediation in the remaining sub-areas. Policy issues relating to the Hook and Open Space parcels need to be resolved and are in discussion with the NDEP.

7. Planned Modifications to Remedial Actions

None planned.

- Additional Evaluation of Metals. BRC preparing a revised package, with input from Dr. Jonathan Myers. Expected submittal date is July 31, 2011.
- Southern RIBs Risk Assessment. DU/COPC selection portion of HRA. BRC expecting NDEP comments before July 15, 2011.
- Galleria North High School Site. Metals evaluation in progress. See first item above.
