The Nevada Division of Environmental Protection (NDEP) has reviewed the March 12, 2008 *Technical Memorandum – Data Review for 2007 Parcel 4A Investigation* ("Data Review") and May 2, 2008 *Errata Pages for Technical Memorandum – Data Review for 2007 Parcel 4A Investigation* prepared under the responsible charge of Dr. Ranajit Sahu, CEM of Basic Remediation Company ("BRC") on behalf of BRC for the above-referenced area and more specifically as depicted on Figure 1 of the Data Review and in the legal description and exhibit attached to the April 4, 2011 e-mail from Mr. Lee Farris of BRC. The Data Review contains a request for a no further action determination from the NDEP.

The NDEP has reviewed the following information and has determined that no further assessment or remediation of soil is required:

- 1. A voluntary Environmental Covenant ("EC") has been prepared and executed in accordance with Nevada Revised Statutes 445D relating to the prospective use of the subject property;
- 2. A screening level human health risk assessment; and
- 3. Supporting technical data.

The EC was recorded as of February 3, 2011 with the Clark County Recorder office for the area designated above and therefore is a matter of public record.

This determination modifies and supersedes the May 15, 2008 NFA issued by the NDEP for Parcel 4A.


