No Further Action Letter

Dear Mr. Lindquist,

The NDEP has received and reviewed BEC's aforementioned report and find that No Further Action is required at this time with the following conditions:

- 1. Access must be maintained for the TIMET site, which utilizes existing roadways for access to the active industrial facility.
- 2. TIMET must be granted access to the existing monitoring wells that are located on the TRECO property. Furthermore, future site development must not disturb the existing monitoring wells without consultation with the NDEP and TIMET.
- 3. TIMET retains the responsibility to address any environmental impacts to groundwater beneath the TRECO property. As such, additional investigation may be necessary on the TRECO property as it relates to TIMET's responsibilities. TIMET must be granted access to the site for activities such as well or soil boring installations or other investigative or remedial efforts.

- 4. The site soils beneath 10' below ground surface have not been evaluated to date. The property owner should note that these soils should not be disturbed without additional investigation or evaluation.
- 5. To limit liability, the property owner should ensure that site activities do not exacerbate existing, sub-surface, environmental conditions.
- 6. The site use is suitable for purposes of commercial or industrial use only.
